Lighthouse Organizes First Annual White Cane Day Walk in Fort Worth

On October 13, 2009 approximately 100 individuals had the privilege to participate in the first annual White Cane Day walk in Fort Worth. The intent of the walk was to celebrate the independence of residents in our community that contend with vision loss. A committee comprised of representatives from National Federation of the Blind, American Council of the Blind, Lions Club International, Prevent Blindness, Division for Blind Services, Computers Made Easy, and The Lighthouse for the Blind of Fort Worth coordinated the event. Prior to the walk, many of the participants gathered at the Lighthouse for the Blind of Fort Worth and were provided with commemorative shirts to honor the event. The Fort Worth Transportation Authority, known locally as The T, provided two buses to transport participants to the Tarrant County Courthouse where an opening rally initiated the event. After a welcoming speech by members of the American Council of the Blind, a representative from the Tarrant County Commissioners Court read a White Cane Day proclamation for Tarrant County. After the proclamation was read, the walk began. The walk concluded at a local downtown restaurant four blocks from the Tarrant County Courthouse. The closing ceremony included the reading of a State of Texas Senate Proclamation in recognition of White Cane Day by an employee of The Lighthouse for the Blind. A word of thanks and closing remarks were made by representatives of The National Federation of the Blind. A proclamation from the Mayor was read by a member of the City Council at the Fort Worth City Council meeting later that evening.



President Lyndon B. Johnson first observed White Cane Day in 1964 as a reminder to promote courtesy and special consideration to the blind. White Cane Day has since taken on greater meaning as a time to celebrate the independence of the blind and their right to participate fully in society.

Chairman of the Board, Charles D. Little, Ph.D.

Dr. Charles Little is a native Tennessean, born and raised in Nashville. He graduated from high school there in 1966, and attended Tennessee Tech University for his freshman and sophomore years of college.

After his first two years of college, Dr. Little entered the United States Air Force, where he served two years. In 1970, he returned to finish his college degree majoring in business. Upon graduation, he remained at the University of Tennessee to pursue the Masters in Business Administration (MBA). He was awarded that degree in March of 1974 and immediately accepted a position with the United States Interstate Commerce Commission (ICC) in Washington, DC.



Dr. Little served almost ten years as a criminal investigator with the ICC in Washington, Chicago, and Fort Worth, achieving the level of District Director and Supervisor of Investigations over an eight-state area while in the Fort Worth regional office. During this time, he served on major projects and investigations involving such criminal activities as

illegal agricultural cooperatives, bogus brokerage activities, "lumping," weight fraud, and duplicate payments.

Dr. Little was offered the position of Director, Transportation Services with the United States General Services Administration (GSA) in November of 1982. He accepted this position and spent the remainder of his career in various managerial and then executive positions working out of GSA's regional offices in Fort Worth. During the course of Dr. Little's federal career, he led supply projects for military activities in the Middle East, Somalia, and the Falklands and disaster projects

including floods, earthquakes, tornados, hurricanes, and the bombing of the Alfred Murrah Federal Building in Oklahoma City. During his career with GSA, Dr. Little earned his Ph.D. in Organization Theory and Leadership with a secondary in Marketing from the University of North Texas in 1985.

As Dr. Little moved through his career with the GSA, he developed a special interest in the National Industries for the Blind (NIB). He worked closely with the Blind Workshops in Texas, and he built a close working relationship with the Lighthouse for the Blind of Fort Worth. He and his business development staff, actively promoted blind made products to the over 54,000 federal customers located over the eleven state area of his region. He often spoke at federal customer meetings promoting blind made products, and he regularly attended NIB and Lighthouse Industries for the Blind of Texas (LIBT) meetings, in order to strengthen the working relationship between he and his business development staff and the blind workshops located in Texas, the Southwest, and nationally. He received numerous awards from NIB and the NIBT during his career with GSA.

In July of 2004, Dr. Little retired from the U.S. General Services Administration in order to accept the position of Associate Dean of Business at Texas Wesleyan University. He left that position in May of 2008 to accept his current position of Senior Lecturer in the Department of Marketing and Management at Texas A&M University-Commerce.

Despite his retirement from GSA, Dr. Little remains committed to the mission of the National Industries for the Blind, and in particular, the mission of the Lighthouse for the Blind of Fort Worth. In 2006, Dr. Little was selected as a board member of the Lighthouse for the Blind of Fort Worth. He was selected to serve as Chairman of the Board for 2010/2011. In this position, he hopes to be able to continue his support of the Lighthouse, and work in concert with the board and Lighthouse leaders to take the organization to new levels of success in the coming years.

LIGHTHOUSE SUPPLIES ENERGY PAD FOR RELIEF EFFORTS

The products made with blind labor, here at the Fort Worth Lighthouse, have been an important component for relief efforts for more than 10 years in such places as Bosnia, Iraq, Afghanistan, Africa and just recently Haiti. If you witnessed air drops of food and water over Haiti you have seen one of our blind made products in action. Each layer of water bottles dropped or meals ready to eat were padded for impact by our Energy Pad product. If you saw or heard of humanitarian relief efforts anywhere in the world you saw our blind made product playing a very important part in saving lives. The Lighthouse for the Blind is the only qualified source in the world for the TRIADS (Tri-Wall Aerial Delivery System Kit) and (Energy Dissipating Pads). The Lighthouse has sold the Energy Pad product, through brokers, to Australia, Singapore, Egypt and the Netherlands for their military air drops and humanitarian relief.

Oscar Olvera Named 2010 Lighthouse Employee of the Year

Our Employee of the Year was born 50 years ago to a large family. Oscar Olvera has four sisters and four brothers. He was born in Allende (ay-en-day) Coahuila (co-ah-we-la) North Mexico. Oscar enjoyed playing soccer as a young child in Mexico with his siblings. In adulthood, Oscar worked as a welder in Houston, Texas. Oscar married his wife, Dora Elia Olvera in 1980. Dora Elia and Oscar gave birth to their only child, Oscar Junior in 1981. Oscar moved to the Fort Worth area in 1987 where he had a number of different occupations in construction, landscaping, and housekeeping.

Oscar was diagnosed with a brain tumor in 1978. That tumor started to substantially impact his vision in 1985. Oscar started working with the state agency for the blind, the Texas Commission for the Blind, now Division for Blind Services, in 1998 and later started working with us at the Lighthouse for the Blind in 2003.

Oscar stated that he enjoys his position at the Lighthouse for the Blind of Fort Worth because he enjoys working with others with vision loss and specifically mentioned that he enjoys working with his direct supervisor, Mr. Rick Watkins. When nominations for Employee of the Year were submitted, Rick said that Oscar is "Highly productive and entirely self motivated." Oscar's excellent attendance record was also acknowledged as was the fact that he is always flexible and willing to learn new tasks. Oscar has excelled in his department and consistently performs an outstanding job. Oscar's supervisor and others that voted said that Oscar Olvera certainly merits being awarded the Lighthouse for the Blind Employee of the Year.
